

# REQUEST FOR QUALIFICATION LEADING TO THE DEVELOPMENT OF NEW INDEPENDENT WATER PROJECT (IWP) IN AL GHUBRAH, SULTANATE OF OMAN



Oman Power and Water Procurement Company SAOC (OPWP), a member of Nama Group, is responsible for procuring new capacity for power and water and for purchasing and selling the output in the Sultanate of Oman in accordance with the requirements of the law for the regulation and privatisation of the electricity and related water sector promulgated by Royal Decree 78/2004 (as amended) and OPWP's licence. OPWP is planning the addition of a new water desalination capacity of approximately 300,000 m<sup>3</sup>/day (66 MIGD) which will be located at Al Ghubrah, Muscat, Sultanate of Oman. The IWP is to be developed as a private sector project by an appropriately qualified developer. OPWP is announcing the launch of the qualification process for developers through the launch of the Request for Qualification ("RFQ") document.
